# OUR HISTORY

The Marlborough Boys Club Inc. opened its doors in a rental hall in 1944. Just two years later in 1946, the Club was chartered as a member of the Boys & Girls Clubs of America. Then in 1972 the Club was transformed into a year-round operation, adding programs, staff and a full-time Director. By 1983 the Club's Board of Directors voted to purchase the vacant Mitchell School on Pleasant Street (where our Marlborough Clubhouse is still housed today).

Throughout the 1990's Marlborough Boys Clubs Inc. became the Marlborough Boys & Girls Clubs Inc. and also merged with Girls Inc. in 1999, the Hollis Street Clubhouse in Framingham opened, focused on serving middle school students, and the organization became the Boys & Girls Clubs of Greater Marlborough. One year later the Boys & Girls Clubs of Greater Marlborough, Inc., Boys & Girls Clubs of Hudson, and the Hudson Youth Center merged to finally become the **Boys & Girls Clubs of MetroWest**.

Since then, the Hudson Clubhouse underwent a two million dollar expansion and the Framingham Clubhouse moved to Pearl Street then to Clinton Street. Today, the Boys & Girls Clubs of MetroWest is one of the largest Boys & Girls Club organizations in the Commonwealth of Massachusetts, serving over 3,200 members at our three Clubhouses in Framingham, Hudson and Marlborough.

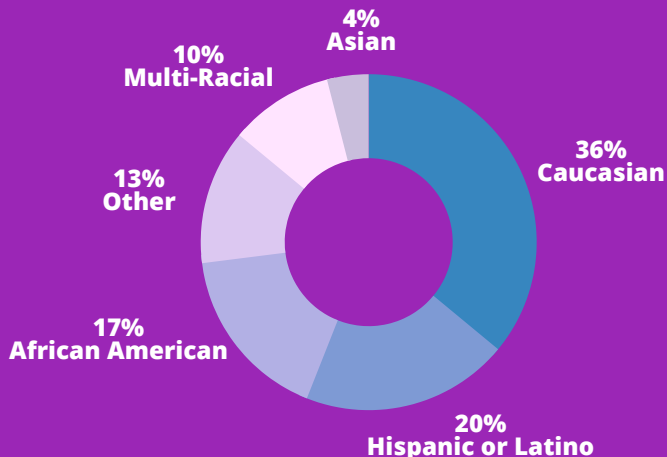

Each individual board member is expected to:

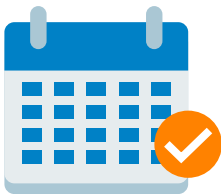
- Understand the organization's mission, policies, programs, and needs

# MEETING OF THE BOARD OF DIRECTORS



## Annual Meeting

The Annual Meeting of the Board of Directors shall be scheduled and held in March for the purpose of electing Directors, and for the transaction of such other business as may come before the meeting.



## Regular Meetings

At least six (6) Regular Meetings (one of which will be the Annual Meeting) of the Board of Directors shall be scheduled and held each year, at such times and places as designated by the Board President and the BGC MW CEO. Regular Meetings traditionally and usually occur on the fourth Tuesday of the month, lasting approximately one hour.



## Special Meetings

Special Meetings of the Board of Directors may be called by the President or a majority of the Executive Committee at any time.

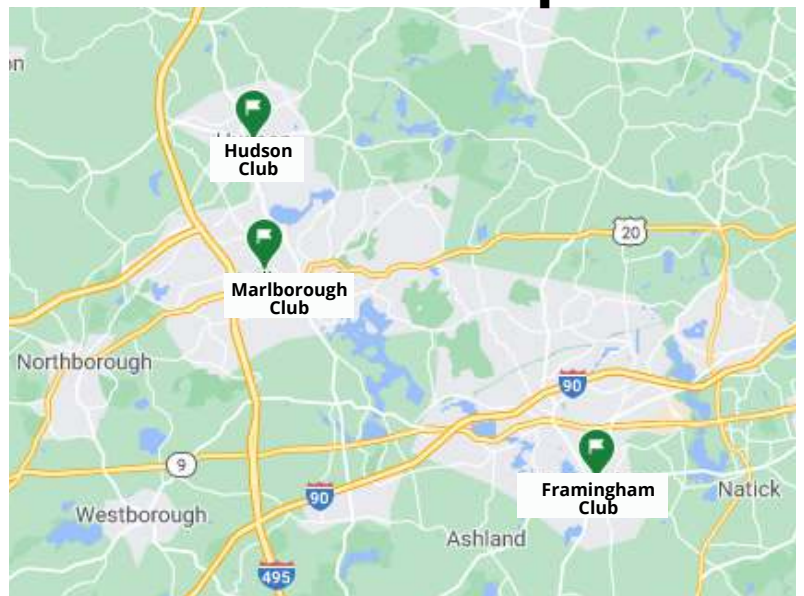
